Terms & Conditions

These Terms & Conditions apply to all Rudolf Couture courses including Traditional Tailoring Techniques, Pattern Drafting & Design and Advanced Garment Construction.

1 General

The Terms & Conditions set out herein shall take effect on 31 May 2015. Terms & Conditions may be updated and/or amended without notice. Any such changes shall take effect on the date they are made and will not affect enrolments processed and invoiced prior to that date. By you submitting an enrolment form and making a payment in accordance with points 2 and 3 below, it will be deemed that you agree to these Terms & Conditions.

2 Enrolment

You will need to submit your details asked for on the enrolment form either by e-mail or by conventional mail on a completed enrolment form. No payment is required with your enrolment. Once your enrolment has been processed and approved, you will be sent an invoice for your course fee.

3 Payment

To confirm your enrolment, payment in full is required within 7 days from the date of invoice or on the first day of your course, whichever occurs first. Payment options will be shown on the invoice. Failure to pay within 7 days may result in your enrolment being cancelled without notice. Any payments made are non-refundable.

4 Transfers

Your enrolment is valid for the selected course only. Should you be unable to commence your course for whatever reason, you may request to have your enrolment transferred to another course at a later date (subject to availability). The rescheduled course must be commenced within 6 months of the date of invoice. After this period has elapsed, any payments made and any unused lessons will be forfeited. Transfers may be applied for on one occasion only and are not available for courses that you have already started.

5 Cancellations

Your course times are confirmed from the time payment of your invoice has been received. Students who arrive late or fail to attend classes during the scheduled times will forfeit any lost time and any payments made for missed lesson(s).

In extenuating circumstances, lessons may be cancelled by us. If this event occurs, the cancelled lesson will be rescheduled to a later date.

6 Privacy

Private information you provide as part of your enrolment will be used exclusively to process your enrolment and will be stored in a database. All reasonable steps will be taken to maintain the security of this database. No information contained therein will be shared with, made available to or sold to any third party. You may request, in writing, to have your personal information updated or removed from this database at any time.
